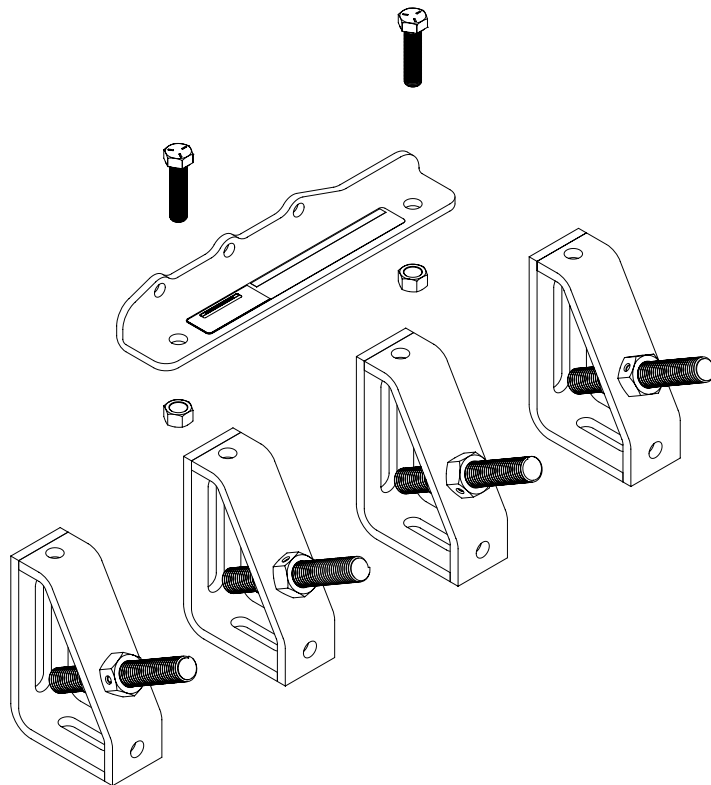

PRODUCT DESCRIPTION

The Fuller Transmission Adapter is designed to be used, in conjunction with the Hein-Werner HW93718, to facilitate removal and installation of Fuller Road Ranger Transmissions with the PTO.

This kit includes:

- Four (4) wedges
- One (1) Fuller Transmission Adapter
- Two (2) 1/2-20 x 1-1/8 Hex Head Bolts
- Two (2) 1/2-20 Hex Nuts
- Four (4) Adjustable Support Rod Assemblies
- One Owner's Manual (this document)



WARNING

- Read and understand all information contained in this Operation Manual before use.
- Before use, verify adapter is not damaged. All surfaces should not be bent, cracked or misaligned. If damaged, discontinue use of adapter.
- Assure load is secured to the device.
- Never exceed rated capacity nor leave loaded transmission jack unattended.
- Do not use in conjunction with equipment or accessories that are not approved by the manufacturer.
- No alterations shall be made to this product.
- Failure to heed these markings may result in personal injury and/or property damage.

BEFORE USE

1. Inspect before each use. Do not use if bent, broken or cracked components are noted. Check for broken welds and misalignment.
2. Before using this product, read the operator's manual completely and familiarize yourself thoroughly with the product, its components and recognize the potential hazards associated with its use.

OPERATION

⚠ WARNING: Use only manufacturer provided attachments and accessories. Ensure all attachments are properly secured. When using bearing punches and other adapters, center the load on the workpiece.

1. Using hardware included in kit, attach two (2) supplied wedges to the Fuller Transmission Adapter.
2. Using transmission hardware, attach the adapter to transmission housing as shown in Figure 1.

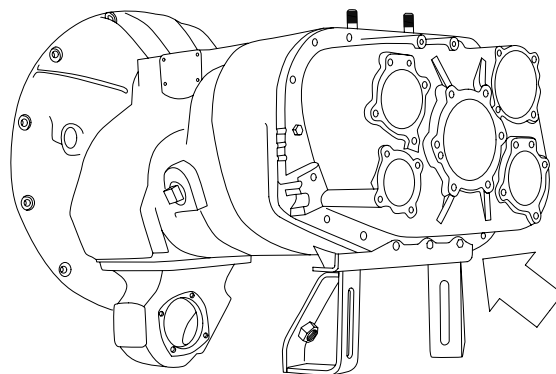

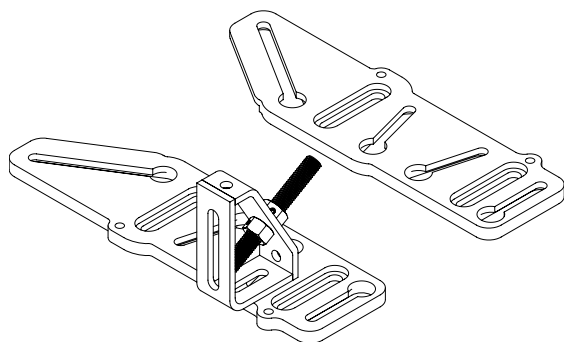

3. Using hardware included with HW93718, loosely attach third wedge, with adjustable support rod, to transmission jack lifting plate as shown in Figure 2.

4. Raise transmission jack platform to contact wedges, adjust support rod on third wedge as necessary, and attach wedges to plate as shown in Figure 3. Tighten all fasteners. Transmission and PTO may now be removed from truck.

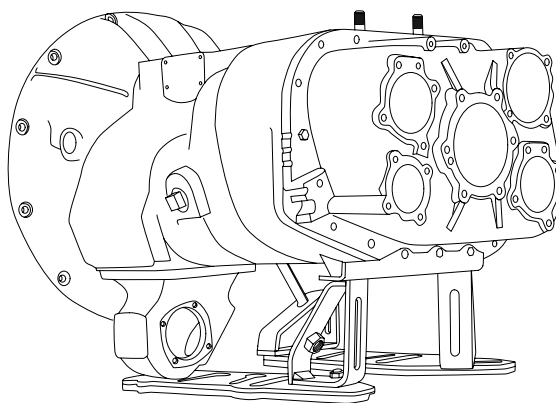
